NOTIFICATION

Whereas the Institute of Chartered Financial Analysts of India (ICFAI), Hyderabad submitted a proposal on 04.03.2005 for establishment of the Institute of Chartered Financial Analysts of India University, Nagaland.

Whereas the proposal of the institute of Chartered Financial Analysts of India has been examined by the State Government on merit and the Government has enacted the Institute of Chartered Financial Analysts of India University, (Nagaland) Act 2006.

AND

Whereas the institute of Chartered Financial Analysts of India (ICFAI), has been directed under sub-section (1) of section 3 of the Institute of Chartered Financial Analysts of India University (Nagaland) Act 2006 to establish an Endowment Fund of Rs.1.00,00.000/- (Rupees ONE CRORE) only.
